Information and Instructions to candidates regarding provisional marks
uploaded on Commission's website

- i. Cut Off Marks for provisional Marks uploaded on Commission's website are as below:
1. For Unreserved - 41.70
 2. For ST category - 40.15
 3. For BC-I category – 28.20

Note : Refer press release dated 11.03.2022 for provisional marks uploaded

- ii. Candidates(whose marks have been uploaded) who are willing to claim for increase in marks and also the other candidates who are willing to claim for increase in marks equal to more than the Cut Off Mark are instructed to email as per Instructions below :
1. For increase of marks from 10th standard to Post Graduation degree : Relevant mark sheets along with copy of provision/rule wherein calculation of percentage is clearly mentioned must be attached if claim for increase of marks is related to consideration of percentage.
 2. For claim of increase in marks for NET/JET/PhD:
 - i. For JRF PhD : JRF award certificate along with document regarding availing this JRF award for PhD awarded.
 - ii. For PhD as per 2009 UGC Regulation with NET/JET without JRF : Proof of PhD awarded as per 2009 UGC Regulation such as Pre PhD Course work certificate, PhD course work certificate, Certificate issued by competent authority for proof of PhD awarded as per 2009 UGC Regulation, Certificate issued by competent authority for clause 5(iii) a to e of the advt. etc. as may be the case along with PhD registration certificate and NET/JET certificate.

- iii. For NET/JET without PhD : NET/JET certificate.
 - iv. For PhD as per 2009 UGC Regulation without NET/JET: Proof of PhD awarded as per 2009 UGC Regulation such as Pre PhD Course work certificate, PhD course work certificate, Certificate issued by competent authority for proof of PhD awarded as per 2009 UGC Regulation, Certificate issued by competent authority for clause 5(iii) a to e of the advt. etc. as may be the case along with PhD registration certificate.
3. For claim of increase in marks for Experience :
- i. For teaching experience : Copy of Appointment Letter/Notification along with Experience certificate issued by Registrar/Principal/Head of Institution. **It is compulsory to attach filled form- A for claim of increase of marks for teaching experience.** Form – A is enclosed herewith.
 - ii. For post PhD research experience :
 1. For post PhD fellowship : Post doctoral fellowship award certificate along with documents related to continuity of fellowship for the claimed duration of experience.
 2. For Research Associate/Research Scientist etc : Appointment Letter and Experience certificate issued competent authority.
4. For claim of increase in marks for Publication :
- a. For published papers in journals and best paper/poster award :
Can be claimed as per schedule - VII of Appendix A of the advt.
 - b. For books and chapters in edited books : Can be claimed by attaching copy of relevant pages of books and chapters being published by University/National Institutes/Standard publishers along with ISBN proof if it is assigned to the books.

Claim for increase of marks must be relevant to information mentioned in sl. nos.-19, 22, 23 and 24 of the application provided for Advt. No. -04/2018

iii. Regarding Caste Certificate:

Caste certificate enclosed with the application are not found to be in order in the following cases:

- a. Caste certificate enclosed with the application is not in form – I or form – II. Caste certificates were sought in form - I or form – II as mentioned in the advt.
- b. Caste certificate enclosed with the application is issued by authority below the rank of Sub Divisional Officer.
- c. Candidate's caste certificate enclosed with the application is not issued on the basis of name and address of father.

All candidates are advised to recheck their caste certificates submitted along with application and if they find that their caste certificates fall under any of the above three cases, then they must submit caste certificate at the time of document verification/Interview(if called) as instructed below :

Submit caste certificate if it is issued in the above mentioned form-I or form – II by Sub Divisional Officer or authority above it on the basis of name and address of father.

OR

For ST category candidates : Issue caste certificate on the basis of name and address of father in form - IV as per circular no. - 1754 dated 25.02.2019 or 1361 dated 03.03.2022 of Jharkhand Govt. and submit it. As per circular No. - 1754 dated 25.02.2019 and 1361 dated 03.03.2022 of Jharkhand Govt. caste certificate in form - IV issued by Circle Officer or authority above it is valid.

For BC-I category candidates : Issue caste certificate on the basis of name and address of father in form XI(FORM OF NON CREAMY LAYER CERTIFICATE TO BE PRODUCED BY EXTREMELY BACKWARD CLASSES/BACKWARD CLASSES APPLYING FOR APPOINTMENT TO POSTS/ADMISSION TO STATE EDUCATIONAL INSTITUTIONS UNDER THE GOVERNMENT OF JHARKHAND) as per circular no. - 1754 dated

25.02.2019 of Jharkhand Govt. and submit it. As per circular No. - 1754 dated 25.02.2019 of Jharkhand Govt. caste certificate in form - XI issued by Circle Officer or authority above it is valid.

iv. **Regarding Interview and Document verification:**

Interview and Document verification is scheduled on 28.03.2022. List of candidates who will be provisionally found eligible of Interview will be uploaded on Commission's website on 26.03.2022.

v. **Last dates for claim of increase of marks, Caste certificate etc. :**

1. Claim for increase of marks have to be submitted through email to email Id - ap42018@jpsc.gov.in till 05:00 PM on 26.03.2022.
2. Claim for increase of marks received after 05:00 PM on 26.03.2022 will not be accepted. Claim for marks increase by other modes i.e. other than email will not be accepted.
3. Caste certificate must be submitted till the time of Interview.

Note :

Claim for increase of marks must be clearly mentioned in content of email and the related documents for claim of increase in marks must be scanned as a single pdf file and has to be attached. Email has to be sent by the same email Id which is mentioned in the application provided for Advt. no. - 04/2018.
